Masters and chief officers of passenger ferries plying in and out of Singapore Port.

COVERAGE OF COURSE

- Navigation in the vicinity of dangerous areas
- Latest Port Marine Circulars and Notices
- Operating in poor visibility
- Communication during emergencies
- Crisis Management in the event of man-overboard, engine/steering failure

PRE-REQUISITE REQUIREMENTS

Must be employed by a local ferry operator as master or chief officer on a passenger ferry.

CERTIFICATION: The Passenger Ferry Safety Course and Assessment Certificate will be re-validated for a period of 2 years on successful completion.
