Each application must be accompanied with the following: 1) A copy of the Certificate of Endorsement (for PLSG(DO) course). 2) A copy of the Certificate of Competency (for PLSG(DO) course). 3) Course fees may be paid by cheque before the stated course date. 4) Payment by crossed cheque, in Singapore dollars, made payable to ST Engineering Training & Simulation Systems Pte Ltd.
